Meeting started at 2.30 pm with Prof. Idichandy on Chair. Chairman welcomed the members and called the meeting to order. The leave of absence of Prof. Sundarrajan, Prof. Vijayakumar K. and Dr. K. C. C. Nair due to pre occupations were approved by the Chairman.

Dr. B. Anil, Principal made a brief presentation of the highlights of major activities of the institution during the period after the last BoG meeting.

The agenda items were taken for discussion and following decisions are made.

BG.14.1. Confirmation of the minutes of the 13th meeting of BoG held on 13th August 2015

The Board of Governors confirmed the minutes.

BG.14.2. Action taken - Reporting of

Action taken based on the 13th meeting of BoG was presented by Dr. Savier, TEQIP Coordinator as per the directions of Principal. The BoG expressed satisfaction over the progress made. BoG recommended formation of scrutiny committee at the earliest for evaluation of international travel proposal. BoG also suggested that the progress made in the action plan and changes, if any shall be presented in the subsequent BoG meeting.

BG.14.3. Status of TEQIP activities – Reporting of

The status of TEQIP activities as on 31st October 2015 was presented by Dr. B. Anil. BoG reviewed the activities and expressed satisfaction on overall progress made in the execution of the TEQIP project. BoG appreciated the institution for organising the Hi Impact Leadership programme by Sri. Shiv Khera.

Anil informed that the possibility will be explored and if possible, it will be conducted as per the suggestion of Board of Governors.

The BoG directed that the status of the air journey sanctioned shall be presented in the subsequent meeting of BoG.

BG.14.7. MoU with Regen Power, Australia – regarding

BoG approved the proposal and recommended to meet the expenses for freight charges, transportation & unloading, installation and service charges from TEQIP through PMSS under services. BoG recommended that as M/s Regen Power is a Foreign Firm, Government approval must be obtained.

BoG also recommended to engage a consultant for providing services for installation of equipment and help the institution in establishing the Centre for Renewable Energy and Energy Efficiency (CREEE) to be met from IOC. BoG recommended that the consultancy charges for establishment of the centre has to be procured through PMSS.

BG.14.8. Non-GATE scholarship for M.Tech. Translational Engineering

BoG examined the proposal and recommended that a detailed proposal in this regard has to be prepared and forwarded to SPFU for placing it before next State Steering Committee (SSC) meeting.

BG.14.9. NBA Accreditation Status – Reporting

BoG examined the status of accreditation. BoG recommended that for eligible courses, SAR must be uploaded before 30th November 2015, without which the institution will lose one point in the next NPIU Review.

BG.14.10. Technical Visit to Masdar City, Abu Dhabi

BoG examined the proposal and agreed in principle for conduct of the technical visit. SPFU director informed that the application for international travel has to be placed before screening committee and scrutiny committee before placing it before BoG. The application in the specified format shall be submitted to the scrutiny committee and get recommendation. BoG suggested that the whole team may be divided into sub groups and should try to concentrate on their area of specialisation. A detailed preparatory workshop has to be conducted before the team conduct technical visit. The outcome of the technical visit has to be presented in the subsequent BoG meetings. Collaborations with universities and research organisations has to be made part of the agenda.

It was also suggested that the number of student members for technical visit shall be increased to 5 and the expenditure may be met from PTA funds and income generated by the institution.

BG.14.11. Student Project Funding - regarding

The BoG examined the proposal of student project funding and approved the same. However, it was recommended that the student project funding has to be utilised for creating research interest among UG and PG students and hence it should not be provided to students for carrying out projects as part of their curriculum. The guidelines for expenditure is as follows:
